ELIGIBILITY

All BWS Signature and Life members may enter regardless of place of residence. Other artists must be 18 years of age or older and must reside in one of the following: Delaware, District of Columbia, Maryland, New Jersey, New York, Pennsylvania, Virginia or West Virginia.

All entries must be original paintings, entirely the work of the entrant, and free from any copyright infringement. No class or workshop paintings. No copies or likenesses of other artists' work. Compositions

based on photographs must use photos taken by the artist or be the sole property of the artist.

Entries must have been completed within the last three years and NOT previously exhibited in prior BWS Mid-Atlantic exhibitions.

Works must be watermedia paintings on natural or synthetic paper or paperboard. No canvas. No water-soluble oils, pastels, photographic, digital or computer processes are permitted. Collage elements are permitted, but must be original work executed on watermedia paper.

SIZE

Minimum image (painting) size is 10 inches H or W. Maximum frame size is 48 inches H or W.

PRESENTATION

Mats must be plain white, cream or light gray with an optional colored liner. Plexiglas must be used for all shipped paintings and larger than half-sheet paintings (approx. 330 square inches). Backing must be archival. Framing must be professional in appearance with clean mats, frames without visible damage, and clean glazing without noticeable scratches. Frames must be suitably wired and ready to hang. Poorly matted or framed works are subject to disqualification.

RIGHTS, RESPONSIBILITIES AND LIABILITY

BWS reserves the right to review all delivered entries for conformance to specifications outlined in the prospectus and the right to refuse any work that does not match the submitted digital entry.

All paintings must be for sale, be priced at your current market value, and committed to the exhibition for the duration. No price changes will be allowed. Paintings that sell during the exhibition may be removed only after the end of the exhibition. A 15% commission will be taken.

Every reasonable care will be exercised in handling the art work submitted. Stevenson University will provide insurance during the exhibit. Shipping insurance is the responsibility of the artist.

In submitting work for consideration, all entrants give permission to BWS and Stevenson University to use images of selected works for publicity, education and reproduction in the catalog.

ENTRY PROCEDURE

1. REGISTER. BWS prefers that you use our online entry process, but you may mail your entry form. Online registration is available through www.baltimorewatercolorsociety.org

2. PAY. Options are as follows:

- Online payment in conjunction with online registration
- Check made payable to BWS and mailed to Sharon Green (address below)

3. SUBMIT DIGITAL IMAGES.

DIGITAL ENTRIES

You may submit one or two images, but only one may be selected for exhibition. Only digital entries will be accepted. Files must be high resolution (300dpi), JPG format, 1920 pixels on the longest dimension, RGB. Name your files LASTNAME-first initial-A or B-title. For example: DOE-J-A-FirstPaintingTitle.

Include your name, address and phone in the body of the message. Or, mail your CD, labeled with your name and painting titles.

If unable to hand-deliver, you will receive detailed shipping instructions. There is NO HANDLING FEE for shipped paintings. AirFloat boxes (or similar) are strongly preferred. Paintings must arrive on May 28-31, 2013.
